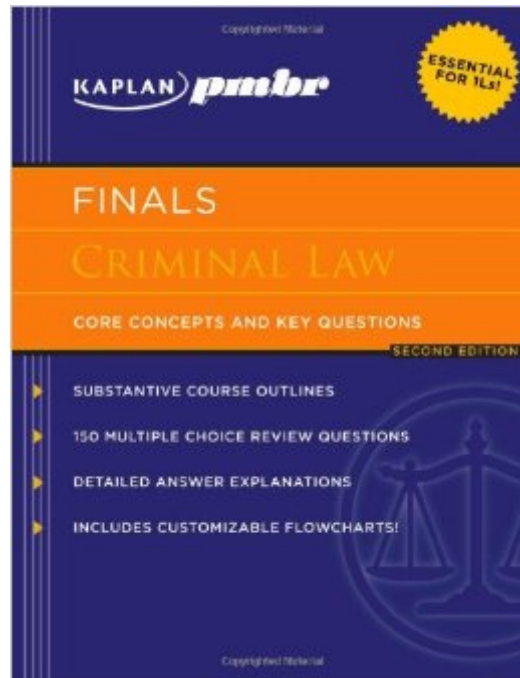

Fantastic review for crim multiple choice. Sometimes a bit too vague, like they offer 'murder' instead of murder 1 or 2 as a choice, which I know my prof was very specific about. Several 'depraved heart' murder questions that made me want to throttle it, but otherwise gives a good general overview needed for practicing timing.

There are 150 multiple choice questions that are accompanied by answers with explanations. The preceding review outlines are concise and on point.
